Vom Hamblin Rottweilers LLC (Seller) is very pleased that you have chosen one of its dogs to be a member of your family. The deposit amount is half of the purchase price and is non-refundable. Should the above dog become unavailable at no fault of the buyer, the deposit will be refunded in full. If the dog has been designated as "pet", the buyer agrees to have the dog spayed/neutered at the soonest available age. Registration documents will not be issued to Buyer from Seller until satisfactory proof of spay/neuter has been presented.

Seller warrants that the above dog has been inspected by a licensed veterinarian and has been issued a health certificate declaring it free from detectable health problems. Buyer has 72 hours after taking possession to have the puppy inspected by a veterinarian to determine any serious problems with the dog¹.

Seller guarantees the dog free from hip dysplasia² until 26 months of age. Breeding the dog before two years of age or breeding the dog before being OFA certified will void this guarantee. As the new owner, Buyer is agreeing to provide for the future health and medical attention for this dog. Regular veterinary examinations are strongly encouraged.

Seller does not warrant/guarantee, neither expressed nor implied, the future temperament or personality of the dog. Vom Hamblin Rottweilers LLC strives to breed the finest dogs available with regard to bloodline, confirmation and temperament. However, a dog is an individual and a product of its environment. How you choose to raise your puppy will be the major determining factor with regard to its temperament/personality. You are solely responsible for the people, environments, and situations that you introduce your dog to, voluntarily or involuntarily. Seller will not be held responsible for any damages, settlements, or judgments resulting from the dog. The jurisdiction for any action arising out of this contract shall be the state of Arizona with the venue to be Apache County.

The undersigned agree to this contract in its entirety and it is henceforth binding and controlling upon all matters concerning above described dog.

¹ Additional information and proof of examination by a licensed veterinarian must be presented upon request. After verification, a replacement puppy will be issued or the purchase price refunded at the seller's discretion. Costs associated with the shipping of a replacement puppy will be assumed by the buyer.

² Hip score of fair or better as defined by the Orthopedic Foundation for Animals. The x-ray must be done by a veterinarian who is known as a professional in this field. If the dog does not receive a passing score from the OFA on the first time, a second x-ray must be taken by a different veterinarian and resubmitted to the OFA. If the dog at no time receives a passing score, Seller will provide a replacement puppy. All exam and shipping costs are the responsibility of Buyer.
